- Set up is Fri 12pm onwards or Sat/Sun 8am-9:30am, public entry 10am-4pm

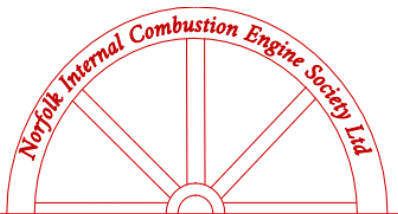

TERMS AND CONDITIONS FOR ATTENDANCE

1. On returning your entry form you accept the Terms & conditions as set out on behalf of yourself and your party.
Submission of an entry does not necessarily mean acceptance.
2. Special requirements must be notified in writing and will be considered by the appropriate Steward. You will be notified if we are able to accommodate your requests.
3. The section steward will allocate a site pitch to you, but will reserve the right to change this at any time.
4. You are required to keep your site pitch and immediate surrounding area free from rubbish and debris. At the end of the rally you will leave your pitch clean and totally free of any rubbish....There are plenty of disposal points around the site.
5. You may only use Entrances/Exits and Rally Ground as indicated by the organisers.
6. You and all members of your party are required to immediately abide by and carry out any instructions given to you by any rally steward, Police or other official.
7. You are required to have public Liability Insurance covering Rally use of not less than **£2,000,000** (**For any one incident**) fully covering your activities at and during the Rally. You will be required to produce evidence of this Insurance for inspection by the Organiser/Section Steward before participating in the Rally. (A photocopy should be sent with your Entry).
8.
 - a) You are only allowed to drive/move your exhibit as directed by an appropriate Steward.
 - b) Passengers may only be carried where the vehicle/exhibit is suitably equipped or adapted for this purpose and when the exhibit is suitably insured.
 - c) Please note that under the provisions of the Road Traffic Act 1988 as amended by the Road Traffic Act 1991 the Rally ground is treated as being the same as a public highway and the same requirements for Insurance, Driving Licences and Road Fund Licences apply.
 - d) Under the Motor Vehicles (Compulsory Insurance) Regulations 1995 all mechanically propelled vehicles, irrespective of size or type, must have an Insurance policy covering liability to third party.
 - e) Dispensations in line with the Motor Vehicles (Off Road Events) Regulations 1995 may be made in respect to authorise operators within the rules & Regulations of the appropriate organisation, federation, society or club in strict accordance with that organisation's code of practice.
9. All pets must be kept on a leash and under control and you remain responsible for them at all time. The exercising of animals on site is forbidden.
10. You will act responsibly and not inconvenience other users of the site.
Bonfires, Fireworks & Ground Level Barbecues are Prohibited.
You are liable for any damage caused as a direct or indirect result of your presence, activities or behaviour on site.
11. We reserve the right to change the location of the rally.
12. Any complaint arising before the rally must be notified to the Section Steward as soon as it is known to you.
Complaints arising during the Rally must be notified to the Organiser on Site Immediately. No complaints will be accepted after the Rally but we welcome constructive remarks that may help to plan future events.
13. We accept no liability for loss or damage to your property, stock, personal, charity or business possessions or damage to any vehicle or exhibit however caused.
14. We reserve the right to refuse entry to the site to any person.
15. **STEAM SECTION.** In addition to the Public Liability Policy your exhibit must be covered by a Boiler Explosion Policy with a limit of not less than £2,000,000 for any one incident and a Sparks & Ashes Policy for not less than £100,000 for any one incident.
The Boiler of any Steam Exhibit must have a current Boiler Inspection Certificate.
Proof of these Insurances must be shown to the Steam steward before participating in the Rally.
